Fishtown Grants & Corridor Cleaning

Over the past year, the Fishtown District was awarded several grants from the City of Philadelphia Commerce Department and Penn Treaty Special Services District (PTSSD).

The Fishtown Kensington Area Business Improvement District was awarded a contract renewal under the City of Philadelphia's "TCB Clean Corridors Program" for \$75,000.00 per year to clean the areas in and around Front Street and Girard Avenue for FY22 (July 1, 2021 to June 30, 2022). It a reflection of the hard work and diligent effort by our cleaning crew from Ready, Willing & Able, to keep this highly trafficked intersection clean and safe for our stakeholders, workers, residents, and patrons, respectively. Finally, special thanks to our District Council members, Darrell Clarke, Mark Squilla, and Maria Quinones Sanchez for their continued support and advocacy on our behalf to continue this necessary funding.



TARGET AREA

Fishtown Kensington Area Business Improvement District will provide sidewalk cleaning services within the Front and Girard, and Frankford Avenue commercial corridors. The area(s) to be served include:

- 1. Front Street from Poplar to Montgomery
- 2. Frankford Avenue from Delaware to Lehigh
- 3. Girard Ave from Front St to I-95

CREW COMPOSITION

The Fishtown Kensington Area Business Improvement District PHL TCB Clean Corridors cleaning crew will consist of:

- 6 Cleaning Ambassadors working 40 hours per week, and
- One Cleaning Supervisor working 40 hours per week

The Fishtown District works tirelessly to ensure that we have a clean, and safe, commercial corridor for all to enjoy. We are pleased to announce that we received a generous grant award of \$11,776, from the Penn Treaty Special services District (PTSSD) to enhance our "Feed the Fish" trashcan program with the installation of 20 new refuse receptacles at locations throughout our community. We thank our 20 business/property owners for agreeing to host and manage these new waste cans, as well as our partners at the Fishtown Neighbors Association (FNA) and East Kensington Neighbors Association (EKNA) for their time and effort in continuing this great program. Finally, this initiative would not be possible without the support of the Board of Directors of PTSSD. The Fishtown District. through the advocacy of Senator Nikil Saval and Representative Mary Isaacson, received a Commonwealth of Pennsylvania "Blight Remediation Planning Grant" of \$14,000 to prepare and coordinate commercial corridor efforts to identify problem real estate parcels, bring them back to productive use.



Masterplan Update for Fishtown District

The Fishtown District hired ISA Architects to develop a corridor "Vision Plan" to beautify, enhance connectivity and accessibility and provide public safety relief, which includes the installation of additional lighting.

The Fishtown Kensington Area Business Improvement District (FKABID) engaged ISA to create a Vision Plan for the Fishtown-Kensington neighborhood in 2020. The goal of the plan is to direct BID resources toward highlighting, amplifying, and expanding the existing cultural, creative, and commercial personality of the neighborhood. Worldclass innovation and creativity across retail, food, and nightlife are what make the Fishtown District noteworthy, and this plan aims to extend that trajectory with a renewed sense of purpose, focus and inclusion.





The Fishtown District draws energy from Philadelphia's highly connected urban fabric, linking Fishtown and Kensington with Northern Liberties, Port Richmond, and other neighboring communities. As the heart of Fishtown expands it is becoming a regional urban center. FKABID member businesses are located along segments of three arterial streets - North Front Street, Frankford Avenue and East Girard Avenue - and while the BID's primary aim is to support and invigorate existing businesses, its broader mission includes outreach to potential new businesses, both from within and outside the neighborhood's diverse voices. This plan therefore includes recommendations targeting the immediate needs of BID corridors alongside the future economic health of the broader neighborhood. The Fishtown District looks forward to bringing these plans to life in 2022 and beyond.



Fishtown District Businesses filled 10 boxes with donations for the Toys for Tots program this year. It was the perfect way to cap off the year in the Fishtown District.

FISHTOWN DISTRICT TRANSPORTATION AND PARKING UPDATE



The Fishtown District understands the parking difficulties in our thriving community and is taking steps, along with Council President, Darrell Clarke & Philadelphia Parking Authority to find reasonable solutions for parking turnover in our district as well as avoiding patrons parking in the neighborhoods. We look forward to continuing to lead and work with the community participants and elected officials to bring these to fruition.

The Fishtown District wanted to ensure that our stakeholders, business owners, their employees, residents and patrons are aware of all parking and travel issues, initiatives and projects being discussed for our commercial corridor and therefore held two virtual meetings this year.

On December 14, 2021, we held our second Parking and Transportation Update. We were joined by a distinguished panel from the Philadelphia Parking Authority, the Philadelphia Streets Department, the Office of Transportation, Infrastructure, and Sustainability (OTIS), PennDOT, SEPTA, the Philadelphia Planning Commission, the Bicycle Coalition, Pennsylvania State Representative, Mary Isaacson (175 Legislative District), and our elected officials who shared information pertaining proposals and projects within our District. Stakeholders and residents were given time to ask questions and provide their input.

On February 19, 2021, we held our first transportation and since this meeting occurred, the PPA conducted the attached Parking Study (with recommendations) for parts of Girard and Frankford Avenues, respectively. The Philadelphia Parking Authority On-Street Analysts (OSA) were tasked with conducting a comprehensive parking survey of all types of parking in the business corridor of the Fishtown neighborhood of Philadelphia, commencing on April 27, 2021 and concluding on May 15, 2021. A comprehensive parking survey is used to gather as much data as possible in order to analyze parking trends. The report as well as video of the virtual meetings can be found on our website at www. fishtowndistrict.com.

Businesses Have Successfully Completed Several Upgrades Thanks To The Storefront Improvement Program

Several businesses, including XYZ have taken advantage of the Philadelphia Department of Commerce Storefront Improvement Grant.

Examples of eligible improvements:

- · Masonry/brick pointing
- · Exterior painting
- · Windows/glazing
- · Exterior doors
- · Exterior facade lighting
- See-through security grills
- · Signage and awnings
- Cornices

The program can reimburse up to 50 percent of the cost of eligible improvements to a maximum of \$10,000 for a single commercial property, or up to \$15,000 for a multiple-address or corner business property.

FISHTOWN DISTRICT ADVOCATES FOR THE EXTENSION OF OUTDOOR DINING

Executive Director, Marc Collazzo, represented the Fishtown Kensington Area Business Improvement District before the Streets' Committee of Philadelphia City Council regarding the extension/permanency of sidewalk cafes and streetery licenses not only for the Fishtown District, but for the entire City. Philadelphia City Council unanimously approved a bill that makes the outdoor dining structures permanently legal in certain parts of the city, and most importantly the geographic parameters of the

Fishtown Kensington Area Business Improvement District.

Under the measure, introduced by Councilmember Allan Domb, eateries located outside of those boundaries would need a district Councilmember to introduce an ordinance and the full Council to approve the measure, keeping intact a longstanding practice known as councilmanic prerogative, which gives lawmakers considerable control over activity in their districts.

We thank our District Council Members, President Darrell Clarke, Maria Quinones Sanchez and Mark Squilla, for their time, consideration, collaboration and support. It was quite clear to the Fishtown District, our colleagues and Council members that outdoor dining is something the public wants as a staple in our City. It was imperative that these outdoor dining options continue, with considerations for safety, design, boundaries, reporting and enforcement.



We will continue to work with our elected officials, Municipal Department Representatives, Stakeholders, Residents, and Community Partners to ensure the continued growth and vitality of our commercial corridor.

FISHTOWN DISTRICT FIGHTS NEIGHBORHOOD BLIGHT

On Monday, November 15, 2021, the Honorable Ann Butchart of the Court of Common Pleas of Philadelphia County granted the Fishtown District's petition to be appointed Conservator under the Blighted and Abandoned Properties Conservatorship Act, after holding and evidentiary hearing, of the vacant real property located at 401-05 East Girard Avenue. We thank our partners, Scioli Turco, https://www.caringpeoplealliance.org/our-programs/scioli-turco/, for all of their hard work and dedication to improving the quality of life in our commercial corridor, and the Fishtown District looks forward to commencing the work necessary to bring this troublesome, neighborhood "eyesore" and returning it to a productive, thriving mix-use building with a dynamic commercial space and upper-level housing units (including affordable apartments). Scioli Turco and the Fishtown Kensington Area BID will return before Judge Butchart on January 21, 2022 at 10:30 a.m. to provide a status of our collective rehabilitative efforts.

Despite the continued growth of our commercial corridor, the effect of vacant, dilapidated buildings adversely affects the fabric of this neighborhood. The Abandoned and Blighted Property Conservatorship Act, also known as Act 135, was put in place to ensure that residents and property owners in a community are able to report substandard or abandoned buildings in order to prevent potential risks or hazards. If there is a blighted or abandoned building in a community, an organization like the Fishtown District can take legal action to mitigate risks and protect the well-being of our citizenry.

Trash collection and street cleaning in the Fishtown District is no small task, but our partners at the New Kensington Community Development Corporation (NKCDC) and the team at Ready Willing & Able (RWA), and the help of a \$75,000 Corridor Cleaning Grant from the Philadelphia Department of Commerce we were able to expand out cleaning crews to 6 days a week throughout the district.

LETTER FROM KAE ANDERSON, **DIRECTOR OF OPERATIONS**



With uncertainty brings opportunity, or at least that's what 2021 has preached to us here at the Fishtown District. As the newest Business Improvement District here in Philadelphia, the pandemic brought with it unique challenges that we never thought we would face in our first two years of operation. While 2021 was not without challenges and restrictions, it would be characterized as a year of opportunity, growth, and resiliency.

While our businesses were reckoning with their own revenue issues, so to were the many governmental agencies and foundations who typically fund our efforts and improvements to the area. Even through these funding insecurities, the

Fishtown District was able to maintain a healthy and secure financial position and with support from the Department of Commerce and Penn Treaty Special Services District.

We also began to move forward with some of the initiatives identified from our 2020 Public Safety Strategic Plan to create a safe and welcoming Fishtown. We supported the 26th District Police as a fiscal sponsor for their series of community events with aim to create more positive non-emergency interactions between our residents and police, as well as hosted trainings for local restaurant and bar staff with private security experts around safety best practices for the industry. In 2022, we will continue to build on these efforts through more entertainment and restaurant staff safety support trainings, security camera installations, and regular safety information updates for our area.

Our district is not an amorphous entity, but a sum of all of the individuals who live, work, and create their lives here. Throughout 2021, the Fishtown District had a chance to highlight these individuals and the stories that lead them to Fishtown through a weekly morning AM radio show and podcast, Find It In Fishtown Live, which also provided useful content for businesses to reuse on their own social media channels. In 2022, we look forward to increasing our marketing efforts, by continuing to share and support your stories, openings, and events, as well as bringing back some of the signature Fishtown and Kensington street festivals, like the Kensington Derby & Arts Fest.

As we continue to build and grow as a neighborhood, the Fishtown District is here to serve you, the people who create and cultivate everything that makes Fishtown unlike anywhere else.
