4. Executive Director Updates

Reauthorization Update: We are waiting on our hearing date, we will not get that date until they are back in session. Once we receive we do our big manilla envelope mailing to all stakeholders. We will ask our supporters to testify, then there is a 45-day objection period with two subsequent readings.

Front & Girard: We are in process of submitting permits, looking for fall installation, fabrication will be happening shortly. Looking to add ambassador hours to staff this, this will be a big part of our budget conversations this fall. Septa will finish in mid-October.

1). FKABID Vision Plan, Part 2;

Looking at Roundabout (4 corners only not touching the middle), Martha St, Lee St, and Girard Ave. Spoke with ISA team regarding the issues on each of these areas that we are trying to address and limitations for each zone. Girard will mostlikely be the first we attempt to activate. Most interestingly the raised trolley platforms, looking to assist with crossings, and vehicular traffic concerns. Will be coming to you all with a rough design in September, then start our working sessions surrounding each activation to get feedback. Goal to finish this plan by 2025.

2). Fishtown/Northern Liberties Connector Project (see attached initial design guide); and

Presented the rough ideas and concepts of the plan, would look to start with funding applications around front and Wildey. Still fleshing out the plan before we do more focus and stakeholder groups.

3). Frankford Avenue Connector.

New bus stop concept, which is being worked into our Letter Seat plan, goal here is to ease approval process and potentially get additional funding. Working on getting pricing to submit then hopefully announce and begin fabrication in the fall.

c). Fishtown District Food Truck Market Update---Pilot Program

New Location: Outdoor Stage Area of the Fillmore;

Tentative Start Date: September 12, 2024
