Who would maintain this?

A: Power would come from the businesses if they agree, but BID would need to pay for the maintenance of this. We will have an understanding of what maintenance costs will be so we can budget for the same.

Lee St: Choice of lighting color will be key here so it doesn't look "cheesy" Are there on/off timing recommendations for the lighting?

LEDs might be easier to maintain over neon.

We would fund these place by place, then installation would follow, so these would not all happen at the same time.

Metal installations seem to be a connector, can that be explored further.

Roundabout: repurposing the F/A signs, can we incorporate the intersection maps on these? Can these be wayfinding oriented? Can we do seasonal decorations? Is the roundabout area worth the investment as it doesn't have a ton of businesses? The seating of marble looks a bit like memorials, let's see some other options for material here.

Martha St:

Conversations regarding the modern design vs something that looks more traditional with the historic site. Can we make the structure a little softer with some curvature? How will it be lit? Is this still functional with trucks? Don't want to take away parking. What does the gate actually say, if anything? only 4-6 spaces right in front of Martha. Looks climbable right now...

Girard:

These look like they might be climbable as well or encourage pull-ups. Will explore turning radius questions, Getting the streets painted properly should be a priority. These feel large and may interrupt sight lines, concerns about providing seating. Massing can calm the traffic and signify the crosswalks. What can septa do vs us?
